This letter serves as a formal legal notice regarding the unauthorized public dissemination, reproduction, and reframing of protected intellectual property authored by Dr. Peter Gaied and protected under U.S. federal copyright and patent law.

The intellectual framework in question is titled the **Gaied Recursive Diagnostic Engine** (**GRDE**). It was developed through closed GPT-based derivation, manuscript submission, and NDA-backed engineering collaboration between March and May 2025. This framework has been actively protected under the following filings:

- Manuscript submissions filed to *Synthese* on April 6, 9, and 15, 2025 (IDs SYNT-D-25-00845, 00864, and 00924)

You have published derivative content under the label **"Recursive Coherence"** and in your document titled *The Fieldprint Framework: Intelligence as a Distributed Coherence Field*, hosted on <u>osf.io</u>, dated April 2, 2025. This document—and associated GitHub repositories and social platforms—contains extensive replication of the following:

- Recursive symbolic grammar developed through GPT-derived GRDE prototyping
- Diagnostic attractor loop logic and phase-based epistemic convergence
- Phrasing and conceptual framing consistent with unpublished projects including:
  - **IPFT** (Inferential Pre-Relativistic Field Theory)
  - Mechanotensile Collapse
  - **QESPI** (Recursive Epistemic Structure of Physical Inference)
  - **GRDE-GGFE** (Emergent Time Derivation)

- **Recursive agent logic (GRDE-MA)** for contradiction resolution and logic compression
- Neurodiagnostic applications in Alzheimer's and pain identity (PLS)

These concepts, names, derivations, and structural signatures were **never released publicly** prior to filing. Their presence in your documents and distributed online posts—including on OSF, GitHub, Reddit (r/systemsthinking), LinkedIn, and X/Twitter—constitutes **unauthorized derivative use**, violation of federal copyright protections, and potential infringement of patentable claims.

# As a result of this unauthorized dissemination, the following damages have occurred:

- **Commercial interference**: GRDE is a commercial-grade utility under NDA-backed development; your derivative release threatens licensing, SBIR grant eligibility, and public rollout

- **Timestamps and platform records** are being preserved and catalogued as part of an active federal intellectual property enforcement file
