While narcissists can **control people's perceptions in small, fragmented interactions**, they struggle **when reality resists their imposed framework**.

- When those perceptions collapse, they have no functional strategy left.

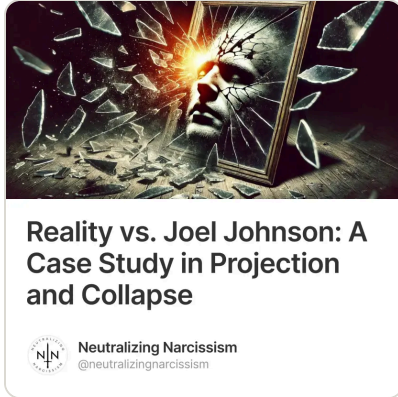
Final Verdict: Why Reality Always Wins
