## 2. The First Rule of a Manipulator: Control the Information

Joel Johnson didn't just disagree with me.

He didn't just try to counter what I said.

He **tried to erase my voice completely.**

He filed false reports.

He triggered an automated takedown.

He weaponized platform systems **to eliminate my work before you could see it.**

Because **if you saw it for yourself, you might have started asking questions.**

But that's not what happened.

Instead, he **tried to take away your ability to think critically.**

Because **once you start thinking for yourself, he loses all control.**

### **4. The Question You Need to Ask Yourself Right Now**

Or you can start asking questions.

And when you do—I **want you to remember this moment.**
