From Walter Anderson's email:

This letter is to serve as formal notification that I, Walter Anderson, am officially submitting my name to run for election to the Board of Directors for Dallas Makerspace for the year 2017.

My goals for 2017 are:

- Get the bylaws rewritten and approved by the membership to address some of the current problems with the document. For instance the current document states that only voting members are allowed to 'influence' the corporation. If this by law were actually followed then only voting members would be allowed to speak at member meetings and board meetings. Clearly this should not be the case, but simply ignoring the by laws forces the board to violate their duties. There are many other issues with the document that should be hashed out with the members to obtain mutually agreeable solutions to these problems and place the space on a firm future.
- Increase savings and ensure that the Makerspace is ready for an inevitable move to a new location and the massive costs that will mean for the corporation.
- Currently the credit cards that are used by all purchasing officers are guaranteed by the personal assets of one board member. This is both an unnecessary burden upon him as well as an unreasonable risk for DMS. I will work to find a solution to this situation so that a \$600,000 per year corporation is independent of the financial support and risk with relying on a single member for such a critical aspect of our existence.

As some of you are aware, I was planning on leaving Texas and relocating to Florida sometime during the summer. I have canceled those plans. I have informed my colleagues that I will be officially fully retired, effective Friday March 24, 2017. This will mean that I can devote a [Skip to main content](#) time to helping to manage the Dallas Makerspace.

As part of this Letter of Intent, I also agree to the duties and functions expected of me in this position that include, but are not limited to:

Making every effort to attend the annual meeting(s) and regular meetings. Perform the duties and responsibilities of Director as outlined in the Dallas Makerspace Bylaws as well as the Dallas Makerspace Rules and Policies. If elected, I am fully aware and understand the importance of my full participation as a productive and effective leader during my tenure on Dallas Makerspace Board of Directors, and I agree to the terms and conditions set forth above.

Thank you for your generous offer. Below is my response to Zach's request. Please [Skip to main content](#) read.



While I understand the desire to focus conversations, I personally believe the idea that we should limit conversation on electronic mediums to be 'on topic' is a fundamentally bad idea. At least as the medium has created tools to do so.

If one looks at traditional conversation between individuals, it is readily apparent, that going off-topic is the normal way human beings interact. It is something to be encouraged, because it is one source of human creativity. Yes, when the conversation is a meeting to discuss/accomplish some specific act; such as a board meeting, there is a need to keep things more focused. I don't believe this is generally the case with electronic communications, since they don't have a time constraint. Further, I believe attempts to split conversations into separate threads further reduces the functionality of the medium since it removes much of the context that created those spawned conversations, as well as making it even more difficult to use limited search functions to find and locate past conversations.

This latter ability is one of the most important features a board like Talk has for DMS. It represents a knowledge base for the members and prospective members. I have been amazed at the detail and quality of the information made available to others in a permanent way. A perfect example is Beau Williamson's recent thread where he provided an amazing amount of information to a gentleman in Europe concerning his method for producing lighted panels. In short, Talk is yet another means we already use to fulfill our primary purpose; education.
